In Memoriam

LEROY E. STRONG, MD

Dr. Leroy Strong passed away September 23, 2014. He earned his medical degree from the University of Michigan School of Medicine. Following his graduation, Dr. Strong began an internship at William Beaumont Army Hospital at El Paso, Texas where he specialized in aviation medicine and ophthalmology. He was active in the US Army Reserve until his honorable discharge in 1984. Dr. Strong retired from the US Army as a Lieutenant Colonel. He completed his residency in ophthalmology at Washington University in St. Louis School of Medicine and then began a private practice for ophthalmological surgery in Grand Rapids, which he continued until his retirement in 2004.

ROY A. DAVIS, MD

Dr. Roy Davis passed away August 31, 2014. He completed his education at Hope College in Holland, Michigan, and earned his medical degree from Wayne State University School of

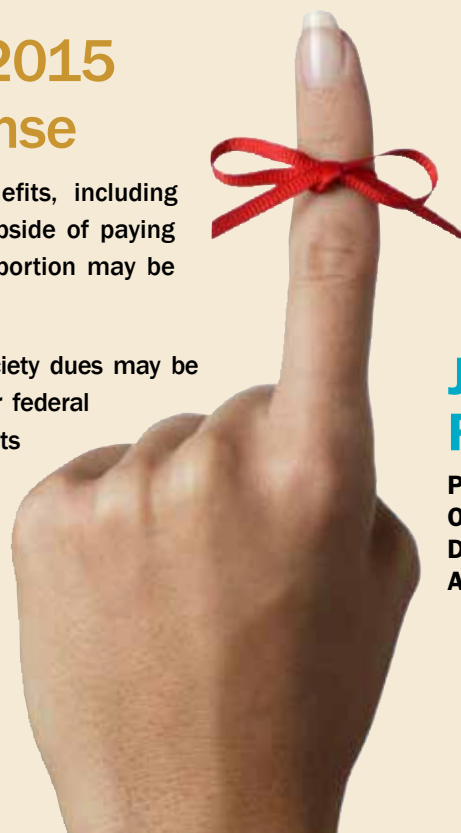

Tax Deductibility of Your 2015 Dues as a Business Expense

PRESIDENT'S MESSAGE

Recibe Más

“Se recibe más de lo que se da” (you receive more than you give) expresses well our family’s sentiment after a recent medical mission in Central America.

Salvadorans seem so grateful for medical care. I’ve heard this said of Hondurans, Peruvians, and Haitians. Even the limited care we can provide prompts sincere gestures of thanks, fruit, eggs, or even the whole chicken. What a contrast to disheartening patient surveys or snarky internet comments at home when we get behind in the office! These patients often travel many miserable miles and wait for hours in the heat while swatting bugs without any complaint.

Leaving behind the EMR, CPT billing, ICD-10 coding, meaningful use criteria, defensive medicine, and demanding regulations to just focus on taking care of the patient prompts considering cancelling the flight home.

Our family has certainly been blessed by participating in medical missions. Just a week in an impoverished developing world country provides tremendous remedy for a United States’ teenager self-centeredness. Exposing our children to international service stimulated a desire to serve beyond anything my high school friends and I ever seemed to consider. This year Sue and I were certainly proud to work alongside our dentist son and daughter-in-law, critical-care nurse daughter, a brother, a nephew and many other families and friends. International friendships have enriched our family and our kid’s facebook contacts beyond imagination.

Many physicians feel their vocation includes teaching. International service work often provides that opportunity. Our team was supported by medical students who served as translators and were most enthusiastic learners. Taking a resident along can

be both helpful for the medical or surgical team and, more importantly, a fantastic educational experience. Teaching a teen to tie a suture may ignite a passion for a career of service

These trips have their costs and concerns though.

Concern for the safety of my family and team does keep me up some nights. Was that a firecracker or a gunshot? Will that barking dog bite? Did that mosquito bite just give the gift of Chickungunya that will keep on giving long after we return? What about my practice back home? Travel is expensive and ever-more-unpredictable. You might not be back to the office Monday...and the list goes on. A service organization with a track record of safety and strong local support seems critical, especially when bringing your family along.

Doctors will be confronted by overwhelming medical problems and lack of resources. The Serenity prayer for the “wisdom to know the difference” helps. The best answer for some problems, particularly as a surgeon, may be not to operate. A well-intentioned procedure might become a disaster for the patient, an impossible problem for the local doctors after you leave, and an unfortunate label for your organization.

Your medications can be confiscated at the border. The cautery unit could be dropped on the floor. The operating lights might go out. Your assistant may pass out. Bugs love to land on your sterile field. You will have to adapt. However, on medical missions you will *recibir más de lo que se da*.

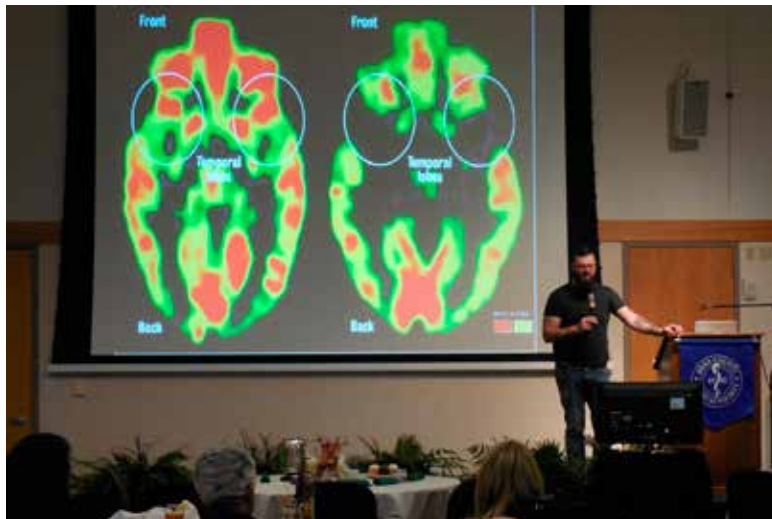

Immunization Reform

The Michigan State Medical Society (MSMS) has been meeting with physicians, public health officials, legislators and media representatives to address the high percentage of non-vaccinated individuals in Michigan. Our State has the distinction of ranking the fourth highest in parents seeking waivers to vaccine requirements.

According to the Detroit Free Press of the 125,000 2013 kindergartners, 7,300 or 5.5% were not vaccinated. One reason that Michigan has such a high number of exemptions is that state law permits philosophical waivers and allows a very liberal interpretation of that law. Four out of five Michigan immunization waivers are for philosophical reasons. School systems now have less than 72% of their young children and 63% of adolescents fully vaccinated. Cases of whooping cough and measles are on the rise.

Families travel and bring back diseases. A major epidemic could sweep across Michigan. In order to protect the most vulnerable in our state a proposal has been filed by the Department of Community Health with the Secretary of State to request changes to the 1978

Michigan Public Health Code. This is being done in accordance with the Administrative Procedures Act (PA306). On November 5, 2014, a Public Hearing was held in Lansing with only supporters in attendance. The rule changes and public responses go to the Joint Committee on Administrative Rules (JCAR) for final consideration. The Department of Public Health must adopt the rule changes before January 1 or the whole procedure must begin again.

In order to protect the most vulnerable in our state a proposal has been filed by the Department of Community Health with the Secretary of State to request changes to the 1978 Michigan Public Health Code.

The modification to the Public Health Code that should have the greatest impact on Michigan's immunization statistics is the addition of informed consent. Each individual requesting an exemption must receive local health education on the benefits of vaccinations and the risks of not receiving the vaccines being waived. All requests must be submitted using the form prescribed by the State and have to be certified by the local health department. Also, if a health official suspects that a student has a communicable disease that student may be excluded from school for a period sufficient to obtain determination of health by a physician or local health officer. All students lacking documentation of immunity or considered susceptible to a communicable disease will be restricted from attending school until there is no risk of disease spread.

MSMS/A is placing immunization awareness as one of its most important projects for 2014-2015. Kent, Muskegon and the Tri-Counties Medical Society Alliances have held public, informational meetings about the need to immunize. Support is needed to push this effort forward. Preparing for Reaccreditation

This year, the Michigan State University College of Human Medicine has been celebrating our 50th anniversary. We have hosted receptions in our campus communities this summer, with the college-wide celebration held in East Lansing, September 19-20, in conjunction with our alumni weekend.

For the first time, we presented a TEDx-style event called MSURx wherein a dozen speakers, ranging from alumni to philanthropists to faculty, shared their stories. Our annual Andrew D. Hunt Lecture began with a 1964-2014 video timeline of the college, followed by a panel discussion from two early College of Human Medicine leaders, Art Kohrman, MD, and Ruth Hoppe, MD. On Saturday, after the annual tailgate, the 50th anniversary celebration continued with our Golden Gala. If you have a chance, visit humanmedicine.msu.edu to see our 1964-2014 video and MSURx.

Another initiative for our college this year has been preparation for our reaccreditation with the Liaison Committee on Medical Education (LCME). In July, the college submitted our self-study to the LCME and in late October, the LCME conducted their College of Human Medicine site visit to Grand Rapids, East Lansing, and Flint. The site visit team met with many students, faculty, and leaders of our partner health care systems. We were told that the LCME team was impressed by the culture of the College of Human Medicine in that we were uniformly student-focused in our approach to medical education. Our health system partners were all very helpful in endorsing the value that the College of Human Medicine has to their communities.

The College of Human Medicine is pleased to be a founding member of the Midwest Interprofessional Practice, Education, and Research Center (MIPERC), in partnership with Grand Valley State University (GVSU), Ferris State University (FSU), and the Grand

Rapids Medical Education Partners (GRMEP). This consortium was recently renamed from its original title, West Michigan Interprofessional Education Initiative (WMPEI), because we now share resources and best practices around the Midwestern states.

This fall, we will engage in our second large interprofessional education simulation, with our third-year MSU medical students, GVSU nursing students, and FSU doctor of pharmacy students meeting together. The students will work through two different cases played by simulated patients.

As most health professionals realize, patients often give different stories to different members of the health care team. In our simulations, students will be charged with planning together how to approach these complex cases, interviewing the patients, communicating about their assessments, and developing plans for care. This exercise received very favorable reviews from the students last spring.

We will be conducting a similar experience and including GVSU physical therapists in the spring of 2015. Our hope is that all of our students learn the importance of communication between health disciplines, as well as the value that each member of the health care team brings to providing quality, patient-centered care. Faculty members from the College of Human Medicine, the GVSU Kirkhoff College of Nursing, and FSU's pharmacy program will make a presentation about this program at an international meeting in the spring.
